Mrs. Cummings and Mrs. Luzzi provided supportive statements for the referendum. Mrs. Luzzi began her employment in Roseland 22 years ago and was always thrilled to be in the school district due to Lester C. Noecker School being a desirable school. She stated this is a special school with special programs. The students come first with the best practices. The HSA and the Board of Education are amazing. The REA, BOE and HSA are invested in the school district. Mrs. Luzzi feels it is a privilege to teach at the school and to come to a beautiful school every day. She feels it is very important for the student's education to keep the class sizes smaller.

HSA Representative and parent, Ms. Benemina Sancivieri, stated the HSA is supportive of the referendum. As a parent, she would not want the classes to be crowded and sees how a neighboring district, Fairfield, is not in a good position and is using trailers which is why she is supportive of the referendum.

Mrs. DePalma, former teacher and resident, moved to Roseland so her children could attend Lester C. Noecker School. She is supportive of the referendum. As a former teacher in Roseland for 35 years, she believes class size is critical, trailers provide a loss in learning and specials are vital to the development of students. It is also the perfect opportunity to roll one bond into another. She believes Noecker School is a gem of the community.

Mrs. Piscitello, teacher and resident, believes working as a teacher at Noecker School is everything a teacher could want. She would like students to have the education that her children had at Noecker School which is a special place.

Mr. Dermenjian, 58 Roosevelt St., asked about the ROD Grant and confirmed the dollar amount and funding for the Out of District student tuition and transportation. Mrs. Muscara stated the district will be funding the payments and Mr. Leone stated the district had funds put aside for this need.
